Oikoumene hope in 2020


When the Faith and Unity Commission met in late April 2020, we commenced with sharing on our living in a closed down world during a global pandemic. As a representative group from NCCA churches, we acknowledged the re-emergence of the 'household' (oikoumene) as an outpost of faith at this time of closed worship spaces. We spoke of the rapid creation of new online spaces and opportunities to come together, in addition to worship, to reflect in bible study and group prayer. We shared on the new openness to reach out and speak to our neighbours, even to ask "Who is our neighbour?"

Flowing from our months of bushfires, we witnessed our pastoral care developed in *oikoumene* on our frontlines. State and Territory-based Emergency Chaplains served alongside other essential health and medical services, accompanying the displaced, lonely, desperate and anxious.

There was an outpouring of compassion and material help for those that missed out on Government financial support, especially refugees and asylumseekers, unable to meet accommodation, food and bill expenses for many months. Around the world, migrant workers bore the brunt of unemployment, discrimination and infection.

As we looked out on our natural world recovering from bushfire and unimpaired by human activity during the COVID lockdown, we saw God's Creation/oikoumene flourishing in a non-polluted, multi-coloured world and started planning for NCCA dialogues on climate, energy and environmental justice. Our First Nations peoples began planning a meeting for churches to renew our mission of reconciliation in Australia and continue the healing ministry of Christ through oikoumene.

We have a way to go yet but may we recognize our **oikoumene** anew as a strength in uncertain times.

Australian Churches Refugee Taskforce

COVID-19 has presented an extremely busy and important time.

The ACRT is located within the larger refugee and asylum seeker sector and has joined in a number of sector-wide advocacy initiatives as well as individual advocacy. This has involved writing letters to the Prime Minister, other ministers and a Senate inquiry into the government response to COVID-19. Communications sought to affirm the government for its response broadly as well as advocating on

several key issues.

Issues have related to:

- 1. The risks faced by people in detention and suggesting they be released into community detention.
- 2. People on bridging visas or people whose visa status is in transition or for whom return to country of origin is not possible.
- 3. Income support and access to Medicare for people on temporary visas. This mainly focused on asylum seekers and refugees (those impacted by loss of employment and not eligible for support) but echoed the larger concerns for migrant workers and international students also impacted.
- 4. We are well served by members from ACRT and our churches more broadly who are working in agencies and organisations that have experienced a dramatic increase in people seeking assistance. This has included crisis housing, financial and rental assistance and food support.

Where possible, we included real-life examples gleaned from across our network.

With a more future focus, the ACRT has been actively part of the Community Refugee Sponsorship Initiative, a coalition of organisations seeking to encourage the Australian Government to develop a new and better mechanism for community groups to be able to sponsor and support refugees in our community.

Lastly, I would like to thank those Church Leaders and your organisations who have spoken out on these matters and provide support to the work of ACRT.

ACT FOR PEACE

Act for Peace is the international aid agency of the National Council of Churches in Australia and is a member of the ACT Alliance, one of the world's largest and most effective networks of grassroots aid organisations and workers with more than 140 member organisations working in over 100 countries.



This year more than ever we are grateful for our dedicated supporters who share our passion for justice, and the goal of seeing communities threatened by conflict and disaster increase their safety, with dignity.

The Financial Year 2019/20 showed the strength of Act for Peace and our partners in the face of an unanticipated significant challenge. As Australians battled drought, bushfires, and floods, a pandemic swept around the world, threatening lives, livelihoods and futures. This pandemic created a shared experience which linked us more closely than ever to our overseas partners. In addition, the #BlackLivesMatter movement brought into focus the horrific ongoing abuse perpetrated against individual human beings and their communities because of the colour of a person's skin.

The novel coronavirus took centre stage for the last four months of the year, Act for Peace continued to retain a focus on safeguarding; prioritising the safety and protection of vulnerable people through each stage of our work. Strategically we chose to support partners to respond to the pandemic while retaining our ongoing commitment to build resilience, and to put into place protection mechanisms which reduce the likelihood of harm from both conflict and disaster recognising that long-term needs, including primary health, job security, and recognition of the rights of people displaced, will remain for the longer term.

This approach helped our partners working in Jordan, Pakistan, Zimbabwe, and other countries, to be on the front foot when preparing for the pandemic. It also helped our partners in Vanuatu and Tonga to reduce the likely devastation caused by Tropical Cyclone Harold.

ACT FOR PEACE

As an ecumenical agency we prioritise collaboration. Act for Peace remained an active member of the international ACT Alliance, the Australian Church Agency Network and their Disaster Operations, our industry body the Australian Council for International Development, the Asia Pacific Refugee Rights Network and in this year we renewed our membership with the Micah coalition and engaged formally with the new Emergency Action Alliance.

Act for Peace paused progress towards our next strategic plan in light of the pandemic and so created space for staff to respond to the changing situation facing our partners. Future planning also now responds to the long-term global disruption caused by the pandemic.

This year highlighted the strength of engagement Act for Peace has with our several institutional donors. This included the Australian Government's Department of Foreign Affairs and Trade, and Department of Home Affairs, who immediately recognised the need to alter some programming agreements to enable partners to respond to the pandemic.

We appreciate their willingness to work with us quickly and flexibly to prioritise the needs of the communities supported by their grants.

The Act for Peace Board and Staff Leadership Team

made the significant decision to delay the Ration Challenge, one of our main events of the year. This decision was made in recognition that our supporters were facing uncertainty. As a result, Act for Peace ended the year with a financial deficit which was covered by reserves and ensured that the communities we serve were not disadvantaged. Thankfully, due to a history of good management Act for Peace's financial position remained strong at the end of the financial year.





SAFE CHURCH PROGRAM



The Safe Church Program (SCP) is an initiative of the NCCA. It is our core business to strengthen relationships across churches/Christian faith communities, government agencies and other bodies to create safer organisations.



In the 2019-2020 period the Safe Church
Program engaged the services of Child Wise —
an organisation which has pioneered the use of
child safety standards in Australia — to consult
with NCCA Safe Church Program members to
develop our National Framework for Child Safety.
The resource will be launched in late 2020.
The Framework will encompasses the UN
Convention on the Rights of the Child, the Royal
Commission recommendations and the National
Principles for Child Safe Organisations.

"Transforming Cultures: Listening, Reflecting, Acting" 17-18 September 2019

The Conference was held at the Mercure Hotel in Brisbane in September 2019. It was a wonderful conference that hosted some of Australia's leading experts across various sectors including the National Office for Child Safety, ACU, ICPS, University of Divinity, SAMASN and Blue Knot to name a few. The conference was sponsored by the University of Divinity, CPSL, Ansvar, Prolegis and CCI.

CPSL and **NCCA** partnership

A formal partnership agreement between the NCCA Safe Church Program and CPSL was confirmed in February 2020 for six months .This resulted in the delivery of some key joint initiatives which have strengthened ecumenical partnerships and developed safeguarding capacity across all our Churches.

The National Coordinator of the Program, Laura Lindsay-Cregan was seconded to work two days a week with CPSL on key safeguarding initiatives. Over the course of the secondment, NCCA and CPSL delivered five joint webinars (three in the series on Grooming Awareness, and two in the Managing High Risk Individuals series) reaching more than 450 participants from at least 18 different Christian groups. The partnership also resulted in the pilot delivery of an adapted Introductory Session for Leaders.



FAITH AND UNITY COMMISSION

The Commission met in Melbourne in November 2019. They met again via Zoom on 23 and 24 April 2020.

The Faith and Unity Commission focused on study documents produced by the World Council of Churches (WCC) and its departments - a prepared response to Moral Discernment in the Churches: A Study Document (Faith and Order paper no.125), and Together Towards Life: Mission and Evangelism in Changing Landscapes, a document of the WCC's Commission on World Mission and Evangelism.

The Commission facilitated the NCCA Member Assembly on 31 October 2019 on Moral Discernment - with presentations from Greek Orthodox Church of Australia, Catholic Church, Uniting Church in Australia and The Salvation Army.

AVECA

AUSTRALIAN VOLUNTEER EMERGENCY CHAPLAINCY ALLIANCE

The Alliance allows for the practical engagement of the Churches with Federa and State governments and community and raises the value and importance of spiritual care in community recovery. AVECA supports capability and capacity building through coordinated and networked resources in the churches.

Breaking Silent Codes:

In March 2020 a group of Indigenous women from Australia, New Zealand, PNG and Pacific Islands travelled to the UN in New York to share knowledge on solutions for First Nations peoples in relation to the topic of sexual assault and family violence.

They were able to share their collective wisdom with US Indigenous women, at a forum held at the New York Baha'i Centre. They were able to meet with key organisations such as Barrier Free Living, Connect and key Native American Elders and representatives of Australian NGOs.


