NCCA PRAYER

National Council of Churches in Australia (NCCA) was formed in 1994 as an unincorporated association, succeeding the Australian Council of Churches established in 1948.

NCCA was incorporated in June 2016 as a company limited by guarantee and has 18 member churches:

Anglican Church, Antiochian Orthodox Church. Armenian Apostolic Church, Assyrian Church of the East, Chinese Methodist Church. Churches of Christ. Congregational Federation, Coptic Orthodox Church, Greek Orthodox Archdiocese. Indian Orthodox Church. Lutheran Church. Mar Thoma Church. Religious Society of Friends (Quakers), Roman Catholic Church, Romanian Orthodox Church, Syrian Orthodox Church, The Salvation Army, and the Uniting Church in Australia.



PRESIDENT'S REFLECTION

The life of the National Council of Churches in Australia (NCCA) in any one year is hard to describe. This review gives an oversight of the various activities of the Council.

We are a small body with a surprising number of elements and activities. At its heart the Council seeks to express the unity that exists among the churches and to do so in the Australian community in ways that affirms relationships, takes matters that are before us seriously and expresses a gracious witness to our common faith.

Our approach flows from our understanding of what it means to be ecumenical. This word 'ecumenical' is derived from the Greek word: 'oikumene' and at the heart of this is 'oikos' which can be translated as "house," "family," "people," or "nation". Oikumene, then, in its fullest use means the whole inhabited earth or the household of all on earth.

We do not use the word 'household' all that frequently. In scripture a household is an inclusive concept – people (both slaves and free), including animals and possessions. There was an assumed diligence in caring for the household and an assumption that households were not chaotic and had rules (codes) and order. All members relied on the functioning of the household for their well-being.

In decades past the concept of us living in a global village was common. Maybe we can extend this and think of ourselves as belonging in a global household.

One implication of thinking in this way is that we are all responsible for each other and for our individual and collective well-being. Individualism is not present in a household. The well-being of one is connected to the well-being of all. A household is inclusive, and through the life of the household all benefit.

So then, whenever we have an opportunity, let us work for the good of all, and especially for those of the family of faith.

(Galatians 6: 10 NRSV)

Exploring what it means to be ecumenical in this sense takes into a focus on about all those matters that impact on the household. As we reflect on the life of the NCCA, and this year in review we can see our activities in the household of Australia and by extension our participation in the global household of God.

In the following pages, the works of Act for Peace, investing with Australia's First Peoples in the Journey from the Heart, the Australian Churches Refugee Taskforce, the Safe Church Program, the Pacific Church Partnership Advisory Network, listening to people of other faiths, advocating for people and communities that are marginalised, caring for creation and the finite resources of our environment, building relationships with governments and strengthening our connections with, and appreciation of each other, are some of our 'household' activities.

In every household not everything works well and not everything is tidy. This is true for the ecumenical movement and for the NCCA. There is more we want to do and some parts of our work that we wish were better and more effective.

Together as members of the household of God, the 'oikumene', we pray, encourage and support each other in our ecumenical life together.

In the lead up to the 11th General Assembly of the World Council of Churches in August 2022, we were encouraged to reflect on the assembly theme: 'Christ's love moves the world to reconciliation and unity'. The theme speaks into this time in Australia and our churches; that Christ's love moves us to reconciliation and unity. Moreover we know that Christ's love impels us. (2 Cor 5:14)

A visible expression of our movement to reconciliation and unity as loved members of the body of Christ is our engagement with the First Peoples of Australia. They are requesting our support for the realisation of the Uluru Statement from the Heart. For the healing of our nation we are committed to journey with them as churches and in our walking and talking acknowledge the intergenerational trauma, discrimination and racism that our First Peoples bear disproportionately. NCCA will continue to work with our Indigenous Christian leaders on the journey to Voice, Treaty and Truth.

On the fifth anniversary of the Uluru Statement from the Heart, 27 May 2022, leaders of Australia's major religious organisations signed a Joint Resolution of support for the Statement from the Heart. Present at Barangaroo in Sydney were leaders from Buddhist, Hindu, Sikh, Muslim, and Jewish organisations and Anglican, Catholic, Uniting Churches and the NCCA.

This public gesture was not just symbolic. The Joint Resolution is a statement of intentional action signalling our support for the coming referendum on the Voice to Parliament with education and opening our spaces for discussion and listening.

The NCCA's advocacy and support for people seeking refuge and protection in Australia is another important outreach that continues with the Australian Churches Refugee Taskforce. This is also a movement impelled by Christ's love to support our communities to be welcoming, compassionate, generous, hospitable with those living with visa uncertainty and distress in our midst.

May the love of Christ impel us to continue to serve 'the least the lost and the last'.

ACRT

The Australian Churches Refugee Taskforce meets monthly via videoconference throughout the year.

The taskforce is made up of 14 people from within our NCCA Church family who are actively involved either organisationally or personally in supporting refugees and asylum seekers in Australia.

During each meeting we receive an update on the key issues that are being felt across the wider refugee support sector as well as updates relating to government policy and programming in this area.

Members share their own work as well as advocacy priorities of their organisations. Opportunities to share wisdom and experience, as well as opportunities for shared advocacy on significant issues is considered.

During the last year the Taskforce's areas of advocacy focused on

- 1. increased humanitarian refugee intake
- 2. closure of all detention facilities
- 3. fair and timely processing of claims for protection
- 4. support for refugees living in community awaiting determination of status
- 5. developing a community refugee sponsorship program that allows and encourages people in communities and churches across Australia to sponsor and support refugees coming to Australia

The Taskforce has been delighted to see the establishment of an annual Refugee Support Grants mechanism by the NCCA Board and we encourage organisations to make applications.



JOINT RESOLUTION - 27 May 2022

"On this day in 2017, Aboriginal and Torres Strait Islander peoples came together at Uluru and asked Australians to walk with them towards a better future.

Through the Uluru Statement from the Heart, Indigenous Australians asked for constitutional recognition through a constitutionally guaranteed voice in their own affairs.

As leaders representing diverse religious communities, we declare our support of the Uluru Statement and its call for a First Nations Voice guaranteed by the Constitution.

We endorse this reform as necessary, right and reasonable.

Indigenous Australians must now be afforded their rightful place in the Australian Constitution.

There have been many processes and much work completed.

The one thing left to do is let the Australian people have their say.

We call on political leaders to take immediate action to hold a

referendum on a First Nations Voice."

FAITH AND UNITY

The Commission engages with the theological work of the wider Church, both to learn and to contribute.

The Faith and Unity Commission met in Melbourne: 21 & 22 September 2021 and 28 and 29 April 2022.

Mandate

To focus, and reflect theologically,

- on the faith that unites us;
- on the Gospel imperative to work towards unity; and
- on the way in which our member (and other) churches can move towards greater visible unity in worship, common life and mission in Christ.

The Commission will:

- invite the Churches to engage in particular projects work to challenge the churches to take specific steps towards unity through engaging with the document Australian Churches Covenanting Together.
- facilitate focussed study on topics when requested by the Assembly.

The Commission assisted with the NCCA Assembly Ecumenical Dialogue held on 28 October 2021 on the question: Where are we at with dialogues as the 'heart' of Ecumenism?



RONALD WILSON ECUMENICAL **LEADERSHIP FUND**


The Ecumenical Leadership Fund assists young people, aged 35 or less eager to enlarge their ecumenical experience and leadership skills.
