9. Guest Speakers

- 9.1 Sylvia Haddad (Monday afternoon) Executive Secretary of the Joint Christian Council for Social Service in Lebanon, Middle East Council of Churches, shared an historical overview of the Palestinian people leading to an exploration of the present day situation of Palestinian refugees in Lebanon.
- 9.2 Monsignor Don Bolen (Monday evening) member of the Pontifical Council for Promoting Christian Unity. The title of this public lecture was Living Together: Fostering a Spirituality of Communion and an Ecumenism of Life.

10. Facilitation Process

The Forum Facilitator gave an overview of the process for the four days of meetings. Members will listen to presentations from the commissions, committees, networks, working groups and other departments of the NCCA. Workshops will take place in small groups, which will lead to the refining of planning for the development of projects and functions within the NCCA for the next three years.

14. Bible Studies

Three Bible Study sessions were presented during the Forum under the sub-themes of *The Prodigal God* (Merryl Blair), *Living the Gift* (Vic Pfitzner), and *The Common Life for the World* (Merryl Blair and Vic Pfitzner). Bible Study Notes for these three sessions were distributed at the beginning of the Forum.

15. Address: The General Secretary of the NCCA

The General Secretary gave two brief addresses that included the session originally reserved for the President's address. (1) *The NCCA: an idea or an ideal?* and (2) *Our NCCA: gathered in pilgrimage.* Each part was followed by table discussions and reflection.²

16. Reporting & Information Sessions

In place of plenary reporting, Commissions, Networks, Working Groups and other NCCA Departments presented to a series of small groups, telling 3 stories about their work, followed by discussion questions:

- Which story is the most significant?
- Why is this story the most significant?
- What questions do we want to ask about the work of the NCCA?

Groups that presented in this way were: Gender Commission, Christian World Service Commission, National Aboriginal and Torres Strait Islander Ecumenical Commission, Commission on Faith and Unity, Social Justice Network, Youth Network, Safe Church Project, Growing Churches in the Australian Context, Interfaith Reference Group and Communications Desk.

Written reports were taken as read, and plenary discussions allowed for questions to be asked of the reports.

17. Presentation by Assyrian Christians

Mr Joseph Haweil and Deacon John Kushaba spoke about the plight of Assyrian Christians in Iraq, particularly northern Iraq. The Assyrian Christian Association has organised a Rally for August 7 outside Parliament House, Canberra.

18. Workshop Sessions

The results of the workshop sessions are available in Appendix A.

19. Reporting Session: Finance

The Treasurer presented the Finance Report, highlighting efforts to enhance the efficiency of the Finance function of the NCCA. New technologies and resources have been engaged. Office space has been reduced in Sydney from two floors to one, involving the loss of the former Boardroom. The empty floor is on the market for sale at around \$1.5 million and proceeds are to be reinvested. CWS continues to reduce its administration costs.

Professional management training will be arranged in 2008 to ensure that all managers have appropriate skills. The NCCA is has a revised pay scale to ensure that all staff are properly remunerated.

There has been a review of risks and service providers to ensure we receive value for money.

The NCCA is solvent and is able to pay its debts as they fall due.

07.07.08 It was resolved that Ron Brown, Wendie Wilkie and Paul Ryan be thanked for the contribution they have made to developing and running the financial systems of the NCCA.

Election of President

.01 (Clause 9.02)

In addition to any other business which may be transacted at a meeting of the National Forum the business of the ordinary meeting shall be:

. . .

[c] to elect the President and not more than six [6] members of the Executive whose nominations for election have been endorsed by their member Churches;

. . .

.02 (Clause 11.02)

The President of the NCCA will normally

[a] be elected by the National Forum;

[b] hold office until the conclusion of the next ordinary meeting of the National Forum and

[c] be eligible for re-election;

In the event that an unexpected vacancy in the office of President occurs between meetings of the National Forum, the Executive may elect the President who will hold office until the commencement of the term of office of a President elected by the National Forum.

Appointment of General Secretary

The General Secretary of the NCCA will be appointed by the Executive, which will also decide the terms and conditions on which the General Secretary is appointed. The General Secretary is also accountable through the Executive to the National Forum.

25. Appropriate Ecumenical Response

11.107.24 It was resolved that this Forum determines, and accordingly instructs its Executive, and requests the State and Territory Ecumenical Councils, to subject all present and future programs and initiatives to a simple test: Is an ecumenical undertaking made at our level the most appropriate response to this matter?

The resolution is made:

conscious of

- o our responsibility for careful stewardship
- o our limited financial resources
- o our past commitments and undertakings which it has not been possible to sustain
- o the important role of State and Territory Ecumenical Councils, and
- o the multiple levels of ecumenical enterprise (international, regional, national, State/Territory and local);

<u>mindful</u> that there is an appropriate locus for every joint ministry and mission initiative (local, State/Territory, national, regional or international on the one hand, and denominational and partly or fully ecumenical on the other);

endorsing the principles that as Christ's people we should

- o do all that we can together and only do apart that which we must do by conscience (Lund principle) and
- o ground our obedience to Christ by shaping and integrating it at the lowest appropriate organizational level in order to maximise its effectiveness (subsidiarity principle);

and <u>acknowledging</u> our own reticence to recognise that some past good initiatives have had their season and need to be concluded in order to release resources for pressing new initiatives.

26. Sustainable Living

$07.07.25^6$ It was resolved that

.01 this Forum of the NCCA notes that, in the words of the Social Justice Network, "It would take several planets to sustain a world population at the current levels of consumption of food, water, energy and goods and the accompanying waste production, of the average Australian. Our Ecological footprint is far too big."

We therefore resolve to ask our Churches and Church agencies:

- 1. to pray our God, the Father of our Lord Jesus Christ, Creator of this world, for forgiveness for our profligate use of the earth's resources.
- 2. to conduct an immediate audit of water and energy use and waste management systems with the view to reducing the 'ecological footprint' of Churches and Church agencies by half as soon as possible.

- 3. to encourage each Christian household in the nation to do the same.
- 4. that we ask the Churches for and point the Churches to the theological resources that underpin this work.
- .02 we ask the Christian World Service Commission to keep in supportive contact with Churches in our region in places where the effect of global warming and changing sea levels will have catastrophic effect, and to report regularly on the conditions in these places.

(accepted with 1 abstention)

27. Communication, Collaboration and Cooperation

 $07.07.26^7$ It was resolved that

- .01 the NCCA Forum asks the Executive to review the ways in which the NCCA supports, and encourages communication, collaboration and cooperation between member Churches with a view to enhancing the effectiveness of this support; and
- .02 in this review, attention be given to the area of public responses to national and international issues, such as global warming and terrorism.

28. Local Mission Developments

07.07.278 It was resolved that the NCCA Forum asks the General Secretary to write to State and Territory Ecumenical Councils asking about existing arrangements for consultation between their member Churches in the decision making process for substantial new local mission developments, e.g. the establishment of new churches, schools and other initiatives, with a view to providing a report on this matter to the Executive.

(accepted with 2 against)

29. Covenanting

11 was resolved that the NCCA Forum commends the work of the Commission on Faith and Unity in developing and working with the document 'Australian Churches Covenanting Together', signed by the NCCA member Churches, and asks that:

- c. the Commission on Faith and Unity consider ways of encouraging and supporting member churches in their commitment to pray for each other.
- d. the Commission on Faith and Unity continue to explore ways in which those churches recognising each other's baptism might build upon this recognition in their practice.

- .05 the National Forum affirms the continuing importance of ecumenical and multi faith collaboration on this issue, including our collaboration with Australian dialogue partners.

- this project be undertaken in consultation with NATSIEC. .04

Rationale:

1. This recommendation comes from the recent Christ and Culture Indigenous Theology Conference organised by NATSIEC.

- 2. It expresses the concern expressed at that Conference about the need to foster the next generation of Aboriginal and Torres Strait Islander leaders. Including as regards the Christian faith formation of future leaders.
- 3. This recommendation is consistent with the goals of the *Make Indigenous Poverty* History campaign, including Goal 2 as regards universal education.
