National Council of Churches in Australia (NCCA) was formed in 1994 as an unincorporated association, succeeding the Australian Council of Churches established in 1948.

NCCA was incorporated in June 2016 as a company limited by guarantee and it has 18 member churches:

Anglican Church, Antiochian Orthodox Church, Armenian Apostolic Church, Assyrian Church of the East, Chinese Methodist Church, Churches of Christ, Congregational Federation, Coptic Orthodox Church, Greek Orthodox Church, Indian Orthodox Church, Lutheran Church, Mar Thoma Church, Religious Society of Friends (Quakers), Roman Catholic Church, Romanian Orthodox Church, Syrian Orthodox Church, The Salvation Army, and the Uniting Church in Australia



### PRESIDENT'S REFLECTION

### GENERAL SECRETARY

#### God-given time

"There is a time for everything, and a season for every activity under heaven." (Ecclesiastes 3:1)

understanding

As someone born, in Australia, during Vatican II and soon after the death of Pope John XXIII, I have grown up with the fruits of the subsequent decades of committed striving for Christian Unity among our Church traditions, even when not fully aware of my inheritance and the significance of our shared birth right as a child of God (Galatians 3:26).

It is a wonderful gift to be working with the NCCA and it has been a blessing to work with our Churches in the Council full-time during this second year of our global pandemic.

This year I have truly been aware of the term 'catholic' in our shared Nicene Creed and Apostolic Creed, meaning 'worldwide' and global. It is probably a stretch for some theologians to claim the term 'catholic' as synonymous to the concept of 'ecumenical' but it has been worthy of my reflection.

Meantime we have been reminded of our calling to be 'apostolic' in this time of a renewed viral pandemic and this has been a pastoral call to each one of us to minister to the isolated, lonely, vulnerable and our own fellow Christian ministers struggling with a loss of identity when traditional ministry had to change significantly this second year from a mere

"getting through" to 'not understanding where we are going and who we will be'. Rather we were asked to respond by "being there for others". (Mark 10: 35-45).

The inevitable acronym 'WWJD' (What Would Jesus Do?) in our trying times has seen us, at difficult junctures with limited resources requiring God-given creativity to work with and for the unemployed; the vaccine-hesitant, the households facing rental stress with risk of homelessness; people dealing with food shortages, mental health, family violence, social connection needs.

We were called through our shared creeds as a 'catholic and apostolic Church' to reach beyond to our 'God-given family' (Galatians 3:26-29) to those strangers in our neighbourhoods and communities in need: including temporary residents like international students, refugees and asylum seekers and those in our Pacific and Asian region suffering greater amount of illness and deaths from COVID-19 and facing unequal access to COVID-19 vaccinations.

We all found this second year, much, much harder than the last. But we have been reminded of our call as a 'catholic and apostolic Church' and we are faithful. God can use every and all time that we give.





ACRT The Australian Churches Refugee Taskforce (ACRT) has been very active during the last year.



Over this period, we have focused on advocacy in several key areas:

- Seeking appropriate government support and fair treatment for refugees and asylum seekers in Australia on temporary visas, impacted in a number of ways, including being unable to work, due to the COVID-19 pandemic.
- Advocating to government for fair and humane treatment of refugees from Afghanistan who are seeking asylum here in Australia but have not been granted residency and are now unable to return to Afghanistan.
- Advocating to government to have a special humanitarian intake of refugees from Afghanistan

### ACT FOR PEACE

#### A year of COVID, conflict and climate related disaster

FY21 was a tumultuous year for many of Act for Peace's partners as they responded to the impact of COVID-19, many working in countries which also experienced increases in civil war and localised conflict, and the devastating impact of climate change.



#### **CPSL** and NCCA partnership

A formal six-month partnership agreement between the NCCA Safe Church Program and Catholic Professional Standards Ltd (CPSL) was completed in August 2020.





The partnership:

- delivered five joint webinars (three in the series on Grooming Awareness, and two in the Managing High Risk Individuals series)
- reached more than 450 participants from at least 18 different Christian groups.
- resulted in the pilot delivery of an adapted Introductory Session for Leaders.

#### **NCCA Child Safety Framework**







In the 2019-2020 period we engaged the services of Child Wise to consult with NCCA Safe Church Program members to develop our National Framework for Child Safety.

The Framework encompasses the UN Convention on the Rights of the Child, the Royal Commission recommendations and the National Principles for Child Safe Organisations.




